










The trestle is available with the following finishing: chromium plated (CRO) or powder coated with polyester varnish black (M7) and milk (M16). Seat and base fixing support in sheet metal.</p> <p>The <b>shell</b> is composed of a plywood panel, moulded and curved, padded with polyuretane foam and upholstered with fabrics chosen by the customer. The upholstery on our chairs is made of flame-retardant fabric and flame-resistant foam.</p> <p>The <b>glide plugs</b> are made of plastic material black coloured or transparent. On request glide plugs with felted surface.</p> <p><b>Packaging</b> (*) is made of corrugated double wave cardboard box and protective elements. It contains 1 pc assembled (1 shell + 1 frame).</p> <p>Fabrics and simil-leather in 1-2-3-4 category as "Materials" folder, downloadable from website.</p>
